Patent Assignment Agreement

between

PFIZER HEALTH AB

and

HEALON AB

THIS PATENT ASSIGNMENT AGREEMENT is made and entered into on this ____ day of June 2004,

by and between

PFIZER HEALTH AB, a limited liability company duly established under the laws of Sweden, corporate identity number 556131-9608, having its registered office at Lindhagensgatan 100, 112 87 Stockholm, Sweden ("Seller"),

and

HEALON AB, a limited liability company duly established under the laws of Sweden, corporate identity number 556604-5422, having its registered office at 751 82 Uppsala, Sweden ("Buyer").

1. Introduction

1.1 On April 19, 2004, Seller and Buyer entered into an asset transfer agreement, as amended ("Asset Transfer Agreement"), under which Buyer agreed to purchase and acquire certain assets from Seller, including all of Seller's right, title and interest in and to the Patents (as defined below).

1.2 In view of the foregoing Seller and Buyer have agreed as follows.

2. Assignment

2.1 For the consideration set forth in the Asset Transfer Agreement the Seller hereby assigns to the Buyer the entire and exclusive right, title and interest of Seller in and to the patents and patent applications listed in Schedule A ("Patents").

2.2 The assignment of the rights in Section 2.1 is complete and includes all rights therein provided by international conventions and treaties and any and all rights of enforcement with respect to the Patents, including all rights to sue and recover for past infringements thereof, and any and all causes of action related thereto.

2.3 The Seller undertakes to execute and deliver, upon request and free of charge, any and all documents, forms and authorizations necessary for the registration of the assignment of the Patents with the relevant registration authorities (in all countries concerned).

- 2.4 The Seller shall pay all fees charged by the registration authorities in connection with the registration of the assignment of the Patents.

3. Miscellaneous

This Patent Assignment Agreement shall in all respects be deemed to be covered by Section 10.7 of the Asset Transfer Agreement on governing law and arbitration.

The parties hereto hereby cause this Patent Assignment Agreement to be duly executed by their respective authorized officers as of the day and year first above written.
