ASSIGNMENT OF INVENTION AND OF LETTERS PATENT

WHEREAS, I, **Gerald Paul Berger**, residing at 7418 Normandy Dr. NE, Cedar Rapids, IA. 52402, am a citizen of the United States and have invented certain new and useful inventions or improvements relating to container filling apparatus including cleaning system for which I have executed an application for Letters Patent of the United States of America, entitled "CONTAINER FILLING APPARATUS INCLUDING CLEANING SYSTEM, filed on **December 14, 2005**, and having been afforded serial no. **11/302,828** by the United States Patent and Trademark Office; and

AND, I HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country of countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said inventions or improvements to the said Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

AND, I HEREBY covenant that I have full right to convey the entire right, title and interest herein assigned, and that I have not executed and will not execute, any agreement in conflict herewith;

AND, I HEREBY authorize and request the attorney of record in the said application for Letters Patent to insert in the above right hand corner of this Assignment the serial number and filing date of the said application when officially known;
