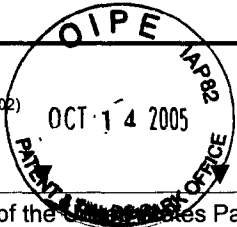



ASSIGNMENT OF INVENTION

WHEREAS I, Mark Licata, have invented certain new and useful improvements in an invention entitled: ONE HAND TOURNIQUET WITH LOCKING MECHANISM, for which a United States Patent Application has been filed on July 29, 2005; and bearing Serial number 11/192,427; priority application being 60/591,947 having been filed on July 29, 2004;

WHEREAS, BioTrack, LLC., having a principal place of business at 800 E. Leigh Street, Richmond, Virginia, hereinafter referred to as ASSIGNEE, is desirous of acquiring certain rights thereunder; and


NOW THIS INDENTURE WITNESSETH, that for a valuable consideration, the receipt of which is hereby acknowledged, I hereby sell, assign and transfer unto said ASSIGNEE the entire right, title and interest in and throughout the United States of America (including its possessions and dependencies) and all countries foreign thereto, in and to said invention (whether patentable or not), of any country, which have been or may be granted on said invention or any part thereof, or any divisional, substitute, continuation-in-whole or in part, renewal, reissue or other patent applications based thereon, and based upon said invention, together with the right of said ASSIGNEE to apply for such patent in its own name in all countries of the world where such is permissible by law, and the right to claim the benefit of priority right provided by the International Convention of 1883, as amended to date, and any such priority right:

AND I do hereby authorize and request the Commissioner of Patents to issue any and all United States Patents which may be granted upon said invention or any part thereof, to said ASSIGNEE;

AND I hereby agree for myself, and for my heirs, executors and administrators, to execute without further consideration any further lawful documents and any further assurances, and any divisional, continuation-in-whole or in part, substitute, renewal, reissue, or other applications for patents for any country that might be deemed necessary by said assignee fully to secure to said assignee its interest as aforesaid in and to said invention or any part thereof, and in and to said several patent of any of them;

AND I hereby further agree to sign and properly execute such necessary and lawful papers for application for foreign patents and inventor's certificates for filing applications for United States, foreign patents and inventor's certificates for subdivisions of any applications for patent or inventor's certificate and/or for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid invention and to perform such further acts as may be required to carry out the intent of this agreement as the ASSIGNEE thereof shall hereafter require and prepare at ASSIGNEE'S expense
