Perky-Pet hereby acknowledges and accepts the assignment and agreement to assign the same.

Barszcz, Fields, Krumpe, Shuchter, and Spencer hereby authorize and request the law offices of Timothy J. Martin, P.C., to insert here in parentheses (Application

number 29/238,444, filed 09-16-2005) the filing date and application number of said application when known.

The Commissioner of Patents is hereby authorized and requested to issue the Letters Patent solely in accordance with the terms of this Assignment to Perky-Pet, its successors, legal representatives and assigns of the entire right, title and interest therein.
