



## PATENT ASSIGNMENT

**WHEREAS, Fujitsu Network Communications, Inc.** (hereafter "Assignor"), having an address of 2801 Telecom Parkway, Richardson, Texas 75082, is the owner of U.S. Patent Application Serial No. 10/116,891 and the inventions described and claimed therein (hereafter the "Patent Property"); and

Assignor also assigns unto Assignee all claims for damages by reason of infringement prior to the assignment date of the Patent Property throughout the world, with the right to sue

for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives.

Assignor also will communicate to Assignee any facts known to it respecting any improvements; and, at the expense of Assignee, will testify in any legal proceedings, sign all lawful papers, execute all provisional, divisional, continuation, continuation-in-part, reissue and substitute applications, make lawful oaths and declarations, and generally do everything possible to vest title in Assignee and to aid Assignee to obtain and enforce proper protection for said Patent Property in all countries.
