ASSIGNMENT AND AGREEMENT



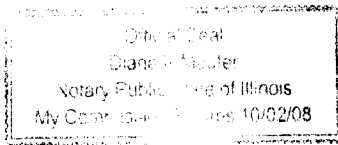
