
1. Said invention in **REVERSE ROTATION PREVENTION DEVICE**;

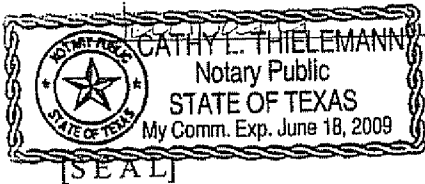




