ASSIGNMENT

WHEREAS we, Trent Lillehaugen and John Temples, 900 Calle Plano, Suite "A", Camarillo, CA 93012, are named co-inventors of a new System For Measuring And Indicating Changes In The Resistance Of A Living Body (hereinafter, the "System") identified by Attorney Docket No. L4069-1400, and for which a provisional application for patent was filed in the U.S. Patent and Trademark Office on March 19, 2003 and assigned U.S. Serial No. 60/455,948 filed (hereinafter individually and collectively the "Application"), and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, we each do hereby sell, assign, transfer and set over to CST (including their respective successors and assigns) all of our right, title and interest in and to the Patent Rights, including all international priority rights arising therefrom, all to be held and enjoyed as fully and completely as the same might have been held by us had this Assignment not been made, and we hereby authorize and request the United States Commissioner of Patents and Trademarks and all non-U.S. patent offices to issue all patents relating to the Patent Rights to CST, and/or its successors and assigns.

We agree that we will promptly, upon request and without further compensation, but at no out-of-pocket cost or expense to ourselves do all lawful acts including the execution of all necessary documents, and the giving of testimony that may be necessary or desirable for obtaining, sustaining, reissuing and renewing said Patent Rights, and for perfecting, affirming, recording, and maintaining the title of CST, and its successors and assigns.


