ASSIGNMENT OF INVENTION

The assignor further agrees without any payment by the assignee other than expenses incurred by the assignor, to communicate to the assignee, its representatives or agents, any facts relating to said invention, including evidence for interference purposes or for other proceedings, whenever requested; testify in any interference, litigation or other proceedings, whenever requested; and execute and deliver, on request, all lawful papers required to make any of the foregoing provisions effective, and likewise make these provisions binding upon its legal representatives, successors and assigns.

The assignor hereby authorizes and requests the Patent and Trademark Office Officials in the United States of America and in any other countries to issue any and all Letters Patents resulting from said application or any continuing, divisional conversion or reissue applications thereof to the assignee, as assignee of the entire interest, and hereby covenants that it has the full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.


