**NUNC PRO TUNC PATENT ASSIGNMENT**

WHEREAS, STERLING COMMERCE, INC. (hereafter "Assignor"), is a Delaware corporation, having an address of 4600 Lakehurst Court, Dublin, Ohio 43017;

WHEREAS, VECTORsgi, INC. (hereafter "Assignee"), is a Delaware corporation, having a place of business at 15301 Dallas Parkway, Suite 400, Addison, Texas 75001; and

WHEREAS, Assignor did enter into one or more agreements (hereinafter "Agreement"), including without limitation a Stock Purchasing Agreement, dated on or about September 11, 2003 regarding ownership of the granted patents and pending patent applications set forth on Exhibit A hereto and the inventions described and claimed therein (hereafter the "Patent Property").

NOW, THEREFORE, pursuant to the Agreement, One Dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor has assigned to Assignee all its rights in and to the Patent Property and to the extent Assignor had any remaining rights in the Patent Properties, Assignor does hereby sell, assign, transfer and set over *nunc pro tunc* to Assignee effective September 11, 2003, all its remaining right, title and interest in and to the Patent Property, as well as all provisionals, continuations, divisions, and continuations-in-part of said Patent Property, and all reissues and extensions thereof, the same to be held and enjoyed by Assignee for its own use and benefit, and for the use and benefit of its successors, assigns, or legal representatives, to the end of the term or terms for which such Patent Property may be granted or reissued, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made.

Assignor also assigns to Assignee *nunc pro tunc* effective September 11, 2003, all right, title and interest in and to the inventions disclosed in said Patent Property throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said Patent Property in its own name throughout the world, including all rights to publish cautionary notices reserving ownership of said inventions and all rights to register said Patent Property in appropriate registries; and Assignor further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Assignee.

Assignors also assign unto Assignee *nunc pro tunc* effective September 11, 2003 all claims for damages by reason of past infringement of such patents, with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns, or other legal representatives.

Assignors also assign unto Assignee *nunc pro tunc* effective September 11, 2003 all claims for damages by reason of infringement prior to the assignment date of the Patent Property throughout the world, with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives.

Assignors will testify in any legal proceedings, sign all lawful papers, execute all provisional, divisional, continuation, continuation-in-part, reissue and substitute applications, make lawful oaths and declarations, and generally do everything possible to vest title in Assignee or its successors, assigns or legal representatives and to aid Assignee to obtain and enforce proper protection for said Patent Property in all countries.

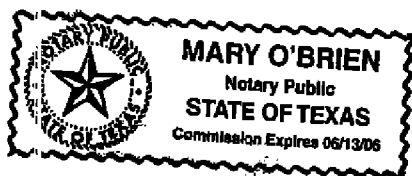
