**PATENT APPLICATION ASSIGNMENT**

FERNWAY LIMITED, a company incorporated in Ireland, owned the entire right, title, and interest in certain patents and technology as originally defined in a 2005 Share Purchase Agreement between certain named persons as Warrantors, Lake Holdings Limited as Seller, Inter-Tel Lake Limited as Buyer and Inter-Tel, Inc. as Parent of Buyer.

Schedule 7 of the Agreement defined Registered Intellectual Property Rights of the Seller and included, *inter alia*, United States Patent Application No. 10/168,030 filed 08 November 2002. By the Agreement, FERNWAY LIMITED does sell, assign and transfer to INTER-TEL LAKE LIMITED, a company incorporated in Ireland, its entire right, title, and interest in the Patent Application, to be held and enjoyed by INTER-TEL LAKE LIMITED, its successors, and assigns.
