ASSIGNMENT

WHEREAS I, Han-il Kim (hereinafter referred to as "ASSIGNOR") of 101, 1690-45 Bongcheon 6-dong, Gwanak-gu, Seoul, Republic of Korea; have invented certain new and useful improvements in:

METHOD OF OUTPUTTING AUDIO SIGNAL FOR THE HARD-OF-HEARING AND MOBILE COMMUNICATION TERMINAL USING THE METHOD

which claims priority to Korean Application No. 10-2005-0014218, filed on February 21, 2005, and for which I am about to file an application for Letters Patent of the United States;
