## ASSIGNMENT

THIS ASSIGNMENT is made on the 20<sup>th</sup> day of December 2005

### BETWEEN

1. **ROBERT JONATHAN HUNT** of PricewaterhouseCoopers LLP of Cornwall Court, 19 Cornwall Street, Birmingham, B3 2DT and **ANTHONY VICTOR LOMAS** and **IAN CLIFFORD POWELL** both of PricewaterhouseCoopers LLP of Plumtree Court, London, EC4A 4HT (the "**MG Rover Administrators**")
2. **MG Rover Group Limited**, a British Company (registered number 1595268) of Longbridge, Birmingham, B31 2TB, GB acting by the MG Rover Administrators (hereinafter referred to as "**the Assignor**"); and
3. **NANJING AUTOMOBILE (GROUP) CORPORATION**, a corporation incorporated in P.R. China of 331 Zhong Yang Road, Nanjing, P.R. China (hereinafter referred to as "**the Assignee**");

### WHEREAS

- A. The **Assignor** is the Registered Proprietor of various Patents ("**the Patents**") Granted throughout the world, brief details of which are set out in Schedule A in respect of Inventions disclosed in the Patent (hereinafter called "**the Inventions**");

- 1.2 all of the rights of the Assignor to and in the Patents, Patent Application and Design Registrations and in any further application for a Patent or Patents in respect of the Inventions, throughout the World;
- 1.3 any Patent in UK or other similar forms of protection granted in respect of the Patent Application or any corresponding application in other countries;
- 1.4 the right to recover and take all such proceedings as may be necessary for the recovery of damages or otherwise in respect of all infringements of any patent or patents granted pursuant to the Patent Application or any further applications whether such infringements take place before or after the date of this assignment;
- 1.5 The MG Rover Administrators are a party to this Assignment in their own capacity solely for receiving and enforcing the obligations, undertakings, waivers and indemnities on the part of the Assignee. The parties agree that MG Rover Administrators have entered into and signed this Agreement as Administrators for and on behalf of the Assignor and the MG Rover Administrators shall incur no personal liability whatsoever whether on their own part or in respect of any failure on the part of the Assignor to observe, perform or comply with any of its or their obligations under this Assignment or under or in relation to any associated arrangements or negotiations.
- 1.6 All warranties, conditions, guarantees or representations express or implied, statutory or otherwise relating to the Patents, Patent Application and Design Registrations including guarantees as to title are hereby excluded, and the Assignor shall not be liable for any loss, damage or expense of any kind whatsoever, consequential or otherwise, arising out of or due to or caused by any defect or deficiencies of any sort in any of the Patents, Patent Application and Design Registrations provided always that nothing in this agreement shall exclude liability for fraudulent misrepresentation.

**TO HOLD** the same unto the Assignee absolutely.


