**PATENT ASSIGNMENT**

This Patent Assignment (the "Assignment") dated as of January 17, 2006 (the "Effective Date") is made by CENTURY INC., a Michigan corporation, d/b/a CENTURY SPECIALTIES ("Assignor"), to CPM ACQUISITION CORP., a Delaware corporation ("Assignee").

WHEREAS, Assignor is the owner of the U.S. patent, and all patent applications therefor, specified in Schedule A attached (the "Patent").

WHEREAS, Assignor, William G. Janis as trustee for the William G. Janis Trust U/A/D March 17, 1979, a Michigan trust, and Assignee are parties to an asset purchase agreement, dated as of January 17, 2006, pursuant to which the Assignor is required to execute and deliver this Agreement;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby sells, grants, conveys, assigns, transfers and delivers to Assignee, and Assignee hereby accepts, all of Assignor's right, title and interest throughout the world in and to the Patent, the underlying inventions described therein and all existing and future design modifications and improvements thereon, and any and all Letters Patent whether U.S. or foreign that are or may be granted therefrom, including, without limitation, any extensions, continuations, continuations-in-part, divisions, reissues, reexaminations and renewals thereof, or other equivalents thereof, and further, all rights and privileges pertaining to the Patent and any and all Letters Patent whether U.S. or foreign that are or may be granted therefrom, including, without limitation, the right, if any, to sue or bring other actions for past, present and future infringement thereof.

This Assignment shall be exclusively interpreted in accordance with and governed by the laws of the State of New York, without regard to its conflict of law provisions. The parties hereby irrevocably and unconditionally submit to the exclusive jurisdiction of the United States District Court sitting in Detroit, Michigan, over any suit, action or proceeding arising out of or relating to this Assignment.

This Assignment shall be binding upon and inure to the benefit of Assignor and Assignee and their respective successors and assigns.

Assignor represents that it has taken all necessary action to authorize the execution and delivery of this Assignment.



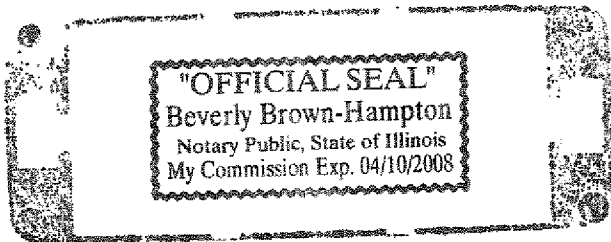
