

Assignor authorizes and requests the United States Commissioner of Patents and Trademarks to record Assignee (or Lodis Accessories, Inc.) as owner of the Patents, including, without limitation, any continuations, divisions, continuations-in-part, reissues, reexaminations or extensions thereof, and to issue any and all letters patent of the United States thereon to Assignee, as assignee of Assignor's entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.


