Now, Therefore, This Indenture Witnesseth, that, for and in consideration of Ten Dollars and other good and valuable consideration, of which I acknowledge receipt, ASSIGNOR, sell and assign to ASSIGNEE, its successors and assigns, the said invention and said application for United States Patent therefor, and any Patent granted therefor, and all divisions, reissues and continuations thereof, and authorize and request the Commissioner of Patents and Trademarks to issue all Patents on said improvements or resulting therefrom to said ASSIGNEE as assignee of the entire interest previously held by the deceased Abraham WARSHAWSKY, and covenant that I have full right so to do, and agree that I will communicate to said ASSIGNEE or its representatives any facts known to me respecting said improvements, whenever requested, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, and reissue applications, make all rightful oaths and generally do everything necessary or desirable to aid said ASSIGNEE, its successors, assigns, and nominees, to obtain and enforce proper protection for said improvements in all countries throughout the world.
