ASSIGNMENT

WHEREAS, I, H. Landis Carter of 1100 Ticonderoga Dr., Greer, SC 29650, am an inventor in certain new and useful improvements in a **DELAMINATION PREVENTION METHOD AND PRODUCT** for which a United States Patent issued on September 10, 2002 under U.S. Patent No. 6,447,902 B1; said invention described therein being hereafter referred to as the "Patent Rights";

I hereby authorize and request the Patent Office to assign my interests in the above identified Patent to JPS Composite Materials Corp. as the assignee of my entire right, title and interest in and to the same.

Further, I will communicate to JPS Composite Materials Corp. any facts known to me respecting said invention, and testify in any legal proceedings, sign all lawful papers, make all rightful oaths, and generally do everything possible to aid said JPS Composite Materials Corp., its successors and assigns, to obtain and enforce proper protection for said invention and Patent Rights in the United States, and in any and all foreign countries.
