And we, do hereby agree for ourselves and for our heirs, executors and administrators to execute any lawful document and to testify as to any material fact or thing which **Mecon Limited** its successors and assigns may deem necessary in order to secure unto itself, its successors and assigns the full right, title and interest in and to and the full enjoyment of said invention or any part thereof and any Letters Patent, the same to be done without any further consideration.
