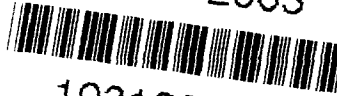
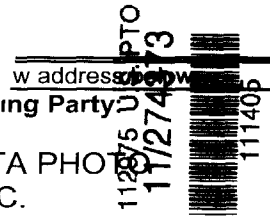

WHEREAS, Yoshifumi MITANI and Naohiko HAYASHI, hereinafter called the "Assignors", have made the invention described in the United States patent application entitled "LENS BARREL UNIT AND IMAGING APPARATUS", executed by Assignors on the same date as this Assignment;

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
