ASSIGNMENT

WHEREAS, GERHARD KLEWEIN, an Austrian National, residing at Rosette Andaystrasse 69, AT-3021 Pressbaum, Austria, THOMAS POLLHEIMER, an Austrian National, residing at Montleartstrasse 42/4502, AT-1160 Vienna, Austria, DIRK BLONDIAU, a Belgian National, residing at Aslangasse 63, A-1190 Vienna, Austria, and GERHARD STOIBER, an Austrian National, residing at Gösting 67A, A-2225 Gösting, Austria, have invented certain new and useful improvements in a **Lens Arrangement for Integration into a Wall, A Wall-Integrated Device Incorporating the Lens Arrangement, and Method of Installing the Device**, for which we executed an application for Letters Patent of the United States of America on even date herewith; and

NOW, THEREFORE, in consideration of the sum of One (\$1.00) Dollar to us in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, we, the said GERHARD KLEWEIN, THOMAS POLLHEIMER, DIRK BLONDIAU and GERHARD STOIBER, have sold assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the said INVENTIO AG, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said improvements, and the said applications and all divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and we hereby authorize and request the Commissioner of Patents and Trademarks of the United States, whose duty it is to issue patents on applications as aforesaid,

to issue all Letters Patent for said improvements to the said INVENTIO AG, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND WE HEREBY further covenant and agree that we will communicate to the said corporation, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to said corporation, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.


