Therefore, premises considered, and for a valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:



IN WITNESS WHEREOF, the parties hereto have executed this Assignment of Patent Rights, or caused the same to be executed on the day and year first above written.


