

AND I hereby covenant that I have full right to convey the entire interest herein assigned, and that I have not executed and will not execute any agreement in conflict herewith, and I further covenant and agree that I will, each time request is made and without undue delay or further compensation whether monetarily or otherwise, execute and deliver all such papers as may be necessary or desirable to perfect the title to said inventions or improvements, said Application, said corresponding applications and said Letters Patent, in the Assignee, its successors, assignees, nominees or legal representatives, and I agree to communicate to the Assignee, or its nominees, all known facts respecting said inventions or improvements said Application(s) and said Letters Patent, and without further compensation whether monetarily or otherwise, and in a timely fashion, to testify in any legal proceedings, to sign all lawful papers, said papers, to execute all disclaimers and divisional, continuing, reissue and foreign applications,

to make all rightful oaths, and generally to do everything possible to aid the Assignee, its successors, assigns, nominees and legal representative to obtain and enforce for its or their own benefit proper patent protection for said inventions or improvements in any and all countries, all at the expense, however, of the Assignee or its successors, assigns, nominees or legal representatives;

AND I hereby authorize and request the Commissioner of Patents of Canada and the United States, and any official of any country or countries foreign to Canada or the United States whose duty it is to issue patents on applications as aforesaid, to issue to the Assignee, as assignee of my entire right, title and interest, any and all Letters Patent for said inventions or improvements, which may be issued and granted on or as a result of the applications aforesaid, in accordance with the terms of this Assignment.




