NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, BE IT KNOWN, that the said ALFONSO SMALDONE, for consideration of \$10.00 (US) paid by said SAFE SKIES LLC, INC. and other good and valuable considerations received by me from said SAFE SKIES LLC, INC., at or before the sealing and delivery of these documents, the receipt of which is hereby acknowledged, have sold, assigned, transferred and conveyed, and by these presents do sell, assign, transfer and convey, unto said SAFE SKIES LLC, INC., its successors and assigns, all my right, title and interest in and to the Invention entitled "OVAL LOCK" in the United States and foreign countries, as set forth and described in the United States design patent application no. 291253609 entitled "OVAL LOCK" filed on or about Feb. 8, 2006, any and all improvements thereon, and in and to any applications to the said Invention in the United States and foreign countries, and any substitute, amendment, renewal, extension, division, continuation, requests for continued examination, continuations-in-part thereof in the United States and foreign countries, and in and to any Letters Patent of the United States and foreign countries which may be issued on any of said applications, and any reissues thereof, including all priority rights from Letters Patent which may be issued in foreign countries and including and priority rights under the Paris Convention, TO HAVE AND TO HOLD THE SAME to the full end of the term or terms for which any and all said Letters Patent may be granted;

AND ALFONSO SMALDONE does hereby authorize the Commissioner of Patents and Trademarks to record the transfer of ALFONSO SMALDONE's right, title and interest of said entire patent application and entire Invention, and to issue any new Letters Patent of the United States or foreign countries or reissues of Letters Patent of the United States or foreign countries, one hundred per cent (100%) to said SAFE SKIES LLC, INC., as the assignee of ALFONSO SMALDONE's entire right, title and interest in and to the same for the sole use and behoof of said SAFE SKIES LLC, INC., its successors and assigns;
