ASSIGNMENT OF PATENTS

In an Order dated September 9, 2005, entered in Matthew T. Mulhern vs. Hans Lem, Quantum Conveyor Systems, LLC (nominal defendant), Superior Court of New Jersey (Chancery Division) (Bergen County), Docket No. C-308-5, I, Steven Z. Jurista, Esq. was appointed Statutory Receiver for Quantum Conveyor Systems, LLC (hereinafter "Quantum LLC") and was vested with title to all property of Quantum LLC of every nature including Quantum LLC's intellectual property and the power to sell, assign, convey or otherwise dispose of such intellectual property.

A request was made by me to the Court to approve the private sale of Quantum LLC intellectual property and, on November 4, 2005, a hearing was held before the Honorable Gerald C. Escala at which open bidding for the sale and purchase of Quantum LLC intellectual property was conducted.

As provided in the "Order Approving Private Sale Of Intellectual Property Assets of Quantum Conveyor Systems, LLC, Subject To Rights Of Paragon Technologies, Inc. and Ermanco, Inc. and Free and Clear of Liens, Claims and Encumbrances," entered on November 4, 2005, by the Honorable Gerald C. Escala, the Court approved the sale of the intellectual property assets of Quantum LLC to TGW-Ermanco, Inc. of 6870 Grand Haven Road, Spring Lake, Michigan 49456, for the sum of one hundred five thousand dollars (\$105,000.00) which amount was then paid directly to me as the Statutory Receiver.



Jurista, as the duly appointed Statutory Receiver of Quantum LLC, effective November 4, 2005, hereby sells, assigns, transfers and sets over to TGW-Ermanco, Inc., its lawful successors and assigns, the entire right, title and interest in and to the following U.S. Letters Patent of Quantum LLC and all reissues, reexaminations and extensions thereof including all rights of recovery for past infringement thereof, said sale, assignment and transfer to be free and clear of all liens, claims and encumbrances:



ORDER APPROVING PRIVATE SALE OF INTELLECTUAL PROPERTY
ASSETS OF QUANTUM CONVEYOR SYSTEMS, LLC, SUBJECT TO RIGHTS OF
PARAGON TECHNOLOGIES, INC. AND ERMANCO, INC. AND
FREE AND CLEAR OF LIENS, CLAIMS AND ENCUMBRANCES

THIS MATTER, having come on before the Court by reason of a notice of motion filed by Steven Z. Jurista, Esq., Statutory Receiver for Quantum Conveyor Systems, LLC ("Quantum") of Mahwah, New Jersey; and it appearing that the Receiver was appointed pursuant to an Order of this Court dated September 9, 2005, and that these proceedings are governed by N.J.S.A. 14A:14-1 et seq.; and it further appearing that the Receiver is titled with all assets of Quantum, including but not limited to its intellectual property assets; and it further appearing that the Receiver has the power to sell said assets per N.J.S.A. 14A:14-5; and it appearing that the Receiver has an offer to acquire the intellectual property assets of Quantum, which sale was noticed to all creditors, parties in

interest, and parties expressing an interest in said assets; and which sale was subject to higher or better offers; it further appearing that Paragon Technologies, Inc. and Ermanco, Inc. (collectively "Exclusive Licensees") having timely filed objections to the Receiver's sale; and the sale of the Quantum intellectual property assets being in the best interest of the within estate; and good cause appearing for the entry of this Order,

IT IS, on this 4 day of November, 2005,

ORDERED, that in accordance with N.J.S.A. 14A:14-5(c), the Statutory Receiver of Quantum Conveyor Systems, LLC, Steven Z. Jurista, be and he is hereby authorized to sell, assign, convey, or otherwise dispose of the intellectual property assets of Quantum subject to certain rights of Exclusive Licensees as set forth in a Settlement Agreement, dated February 10, 2004, between Quantum and Exclusive Licensees said rights being generally referenced in a document entitled "Amended Summary of Settlement Agreement/Exclusive License," which was duly recorded in the U.S. Patent and Trademark Office at Reel 016674; Frame 0775, (a copy of which being attached hereto); and it is further

ORDERED, that in accordance with N.J.S.A. 14A:14-7, the Receiver be and he is hereby authorized to sell or convey the intellectual property assets of Quantum at private sale, free and clear of liens, claims and encumbrances, any valid liens, claims and encumbrances to attach to the proceeds of sale, and it is further

ORDERED, that the sale of the intellectual property assets of Quantum, including but not limited to patents (subject to said rights of Exclusive Licensees), documents, correspondence, drawings, specifications, patent disputes, settlements, licenses, models, tooling, and other pertinent information related to the Quantum

intellectual property be and the same is hereby approved to TGW-Emanco Inc * for
the sum of \$ 105,000.00; and it is further

ORDERED, that the aforementioned sale of the Quantum intellectual property assets shall be free and clear of all liens, claims and encumbrances, valid liens, claims and encumbrances to attach to the proceeds of sale subject to said rights of Exclusive Licensees, and it is further

ORDERED, that the Receiver be and he is hereby authorized to execute any documents or bills of sale to effectuate the terms of this Order; and it is further

ORDERED, that this Court shall retain jurisdiction with regard to any disputes related to the sale of the intellectual property.

AMENDED SUMMARY OF SETTLEMENT AGREEMENT/EXCLUSIVE LICENSE

A Settlement Agreement, effective February 10, 2004, entered into between Quantum Conveyor Systems, LLC, a Delaware corporation ("Quantum") and each of Paragon Technologies, Inc., a Delaware corporation ("Paragon") and Ermanco, Inc., a Michigan corporation ("Ermanco") granted to each of Paragon and Ermanco an exclusive license under each of the following Licensed Patents:
