ASSIGNMENT

Agree, whenever requested, to communicate to said assignees, their successors, assigns, and legal representatives, any facts known to us respecting said rights, to testify in any legal proceeding respecting said rights, to execute all applications, papers or instruments necessary or required by said assignees, their successors, assigns and legal representatives, to carry into effect any of the provisions of this instrument, and generally to do everything possible to aid said assignees, their successors, assigns, and legal representatives to obtain and enforce proper patent protection for said inventions in any and all countries.
