all additional papers which may be requested by said Assignee to fully carry out the terms of this Assignment;

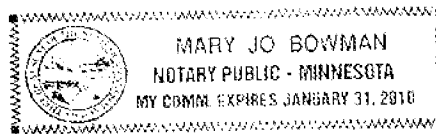
