ASSIGNMENT AND AGREEMENT

FOR VALUE RECEIVED, I, TAPANI LEVOLA, a citizen of Finland and residing at Hyhkynkatu 7 A 1, FI-33270 Tampere, FINLAND, hereby sell, assign and transfer to **NOKIA CORPORATION**, a corporation duly organized and existing under the laws of Finland, and having a principal place of business at Keilalahdentie 4, FIN-02150 Espoo, Finland, as assignee, and its successors, assigns and legal representatives, the entire right, title and interest, for all countries in and to certain inventions relating to improvements in a **DEFFRACTIVE GRATING ELEMENT FOR BALANCING DIFFRACTION EFFICIENCY**, which is described in International Patent Application No. PCT/FI2003/000948 filed on December 12, 2003 and published in English under International Publication No. WO 2004/055556 A1 on July 1, 2004, which claims priority from Finnish Patent Application No. FI 20022199 filed on December 16, 2002; and all the rights and privileges under any and all Letters Patent that may be granted therefor.

I request that any and all patents for said inventions be issued to said assignee, its successors, assigns and legal representatives, or to such nominees as it may designate.

I agree that, when requested, I will, without charge to said assignee but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining patents for said inventions in any and all countries and for vesting title thereto in said assignee, its successors, assigns and legal representatives or nominees.




