WHEREAS

- (B) The Assignor has agreed to assign the Patents to the Assignee.


NOW THEREFORE IT IS AGREED

- 1 In consideration of the sum of two hundred and two thousand one hundred and twenty one Pounds (£202,121), paid by the Assignee to the Assignor, receipt of which is hereby acknowledged, the Assignor assigns to the Assignee, with effect from 31 July 2002, all of the Assignor's right, title and interest in and to the Patents together with all its rights and powers arising or accrued from the Patents including the rights to sue for damages and other remedies in respect of infringements of any of the Patents prior to the date of this assignment, and the right to apply for, prosecute and obtain patent protection throughout the world in respect of the inventions claimed in the Patents including the right to claim priority therefrom to the intent that the grant of letters patent or similar protection shall be in the name of and vest in the Assignee.
- 2 The Assignor undertakes and agrees to execute all documents and do all such acts and things as may be necessary to give legal effect to the assignments hereunder (and the recordal thereof), the costs of which shall be borne by the Assignor and the Assignee in equal proportion.
- 3 This assignment shall be governed by and construed in accordance with English law and the English Courts shall have exclusive jurisdiction in respect of it.
- 4 If the assignment of any patent made in terms of this agreement is held to be illegal or unenforceable, in whole or in part, under any enactment or rule of law, such assignment or


part shall to that extent be deemed not to form part of this agreement but the enforceability of this agreement shall not be affected.
