**TERMINATION AND RELEASE

COLLATERAL ASSIGNMENT
OF PATENTS (SECURITY AGREEMENT)**

THIS TERMINATION AND RELEASE OF COLLATERAL ASSIGNMENT OF PATENTS (SECURITY AGREEMENT) (this "Agreement") dated February 17, 2006, is by WACHOVIA BANK, NATIONAL ASSOCIATION (the "Assignee") in favor of Magruder Color Company, Inc. (the "Assignor").

WHEREAS, pursuant to a Collateral Assignment of Patents (Security Agreement) dated January 18, 2005 between the Assignor and the Assignee (the "Collateral Assignment"), the Assignor granted in favor of the Assignee a security interest in, and collaterally assigned to the Assignee, certain patents of the Assignor which are described in Exhibit A hereto (the "Assigned Patents"); and

WHEREAS, the Collateral Assignment was recorded with the United States Patent and Trademark Office (the "USPTO") on January 25, 2005 in Reel 015621 Frame 0216.

NOW, THEREFORE, in consideration of the foregoing premises, the mutual covenants and agreements of the parties hereto, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignee agrees as follows:

1. Release of Lien. The Assignee hereby assigns, grants and conveys back to the Assignor without any warranty all of its right and title to, and forever discharges and releases its security interest in, all of the Assigned Patents, including all proceeds thereof, the right to sue for past, present and future infringements thereof, all rights corresponding thereto throughout the world, and all reissues, divisions, continuations, renewals, extensions and continuations in part thereof.

2. Recording. The Assignee hereby authorizes the Assignor to file and record this Agreement with the USPTO. The Assignee agrees to cooperate and take further actions, at the Assignor's expense, which may be reasonably necessary or advisable in order to further evidence or effectuate the transaction contemplated under this Agreement, including but not limited to, the execution and delivery to the Assignor of additional forms, instruments or other documents which may be required to file and record this Agreement with the USPTO.

3. Binding Effect. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

4. Counterparts. This Agreement may be executed in any number of counterparts each of which when so executed and delivered shall be deemed an original, but all of which together shall constitute one and the same instrument.
