BETWEEN:

- (1) **AMSAFE BRIDPORT LIMITED** (formerly known as Bridport (UK) Limited) (No. 00140449) whose registered office is at The Court, West Street, Bridport, Dorset DT6 3QU ("Bridport"), **ALAN McLEOD** of Pearsalls Implants, Tancred Street, Taunton, Somerset TA1 1RY and **PETER PHILLIPS** of Anson Medical Limited, The Innovation Centre, 68 Milton Park, Abingdon OX14 4RX (together the "Assignors");
- (2) **PEARSALLS LIMITED** (No.03851227) whose registered office is at Tancred Street, Taunton, Somerset TA1 1RY (the "Pearsalls"); and
- (3) **ANSON MEDICAL LIMITED** (No. 02998639) whose registered office is at 67 Milton Park, Abingdon Oxfordshire OX14 4RX ("Anson").

RECITALS

- (A) By an agreement made between Bridport (then called Bridport (UK) Limited) and Pearsalls (then called Quay Shelfco 733 Limited) dated 4 January 2000, Bridport agreed to sell to Pearsalls the Intellectual Property Rights as defined therein which included its right, title and interest in the patent applications set out in the schedule hereto (the "Patent Applications").
- (B) The Assignors are the joint proprietors of the benefit of the Patent Applications, all of which are proceeding in their names.
- (C) Pursuant to the agreement referred to in Recital A, Bridport is obliged to assign its rights in the Patent Applications to Pearsalls. Pearsalls have now agreed to sell such rights to Anson and the parties have therefore agreed to enter into this agreement so that Anson will become the sole and exclusive proprietor of the Patent Applications.

THE PARTIES AGREE AS FOLLOWS:

1. In consideration of the sum of £1 now paid by Anson to each of the Assignors and to Pearsalls (receipt of which the Assignors and Pearsalls hereby acknowledge) the Assignors and Pearsalls HEREBY ASSIGN to Anson all their respective right title and interest in and to:
 - 1.1 the Patent Applications to the extent that the grant of any patent thereon shall be in the name of and vest in Anson together with all rights and powers arising or accrued therefrom, including the right to sue for damages and other remedies in respect of any infringement of such rights or other acts within the scope of the claims of any published specification accompanying any of the Applications prior to the date hereto; and
 - 1.2 the right to apply for, prosecute and obtain patent or similar protection throughout the world in respect of the inventions claimed in the Patent Applications including the right to claim priority therefrom to the intent that the grant of any patent or similar protection shall be in the name of and vest in Anson.
2. The Assignors and Pearsalls further covenant that they will at all times hereafter do all such acts and execute all such documents as may reasonably be necessary or desirable to give effect to this assignment.

3. This assignment shall be governed by and construed in accordance with English law and the English courts shall have exclusive jurisdiction in respect of it.

IN WITNESS whereof this assignment has been executed on the date first above written.
