FOR THE CONSIDERATION AFORESAID, Assignor has sold, assigned, transferred and set over and by these presents does sell, assign, transfer and set over unto the said Assignee, its successors and assigns, or the nominees of any of them, the entire right, title and interest in and to any and all Letters Patent for said invention which may be granted in countries foreign to the United States, and in and to any applications for Letters Patent which may be filed for said invention in countries foreign to the United States, and in and to the invention described in said applications; and Assignor hereby authorizes and empowers said Assignee and its successors, assigns or nominees, to apply for Letters Patent or other form of protection on said invention in


