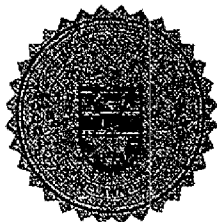

1. The name and jurisdiction of formation or organization of the limited liability company and the corporation which are to merge are:

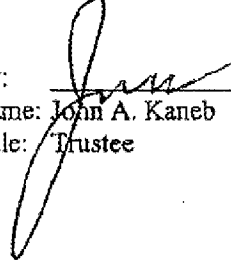
