WHEREAS, Mitsubishi Heavy Industries, Ltd. (the "Assignee"), a Japanese corporation, having its principal place of business at 16-5 Konan 2-chome, Minato-ku, Tokyo, Japan, is desirous to acquire a one third (1/3) right, title and interest in and to the Patent; and

WHEREAS, each Assignor understands and agrees that Assignee may use or license the patent without the obligation of payment of royalties or consideration to Assignors;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, each Assignor does hereby assign unto the Assignee, its successors and assigns, a sixteen and sixty-seven hundredths percent (16.67%) or one-sixth (1/6) right, title and interest in and to the Patent such that each Assignor and the

Assignee each own thirty-three and one third percent (33 1/3%) or one-third (1/3) right, title and interest in and to the Patent.
