


ASSIGNMENT AND AGREEMENT

WHEREAS, Vivid Image Technology, Inc., a California corporation having a principal place of business at 2726 Loker Avenue, West Carlsbad, California 92008, (hereinafter referred to as "ASSIGNOR") has invented certain subject matter described and claimed in U.S. Patent Application Ser. No. 10/804,839, filed on March 19, 2004 by Schoebelen et al.; U.S. Provisional Application Ser. No. 60/554,061, filed on March 19, 2004 by Schoebelen et al.; U.S. Patent Application Ser. No. 10/058,629, filed on January 28, 2002 by Kammerer et al.; U.S. Patent Application Ser. No. 09/144,046, filed on August 31, 1998, by Kammerer et al.; and U.S. Provisional Application Ser. No. 60/079,335, filed on March 25, 1998 by Kammerer et al.; and

WHEREAS, DecoPac, Inc., a Minnesota corporation having a principal place of business at 5736 Main Street, Minneapolis, Minnesota 55432, (hereinafter referred to as "ASSIGNEE") has acquired ASSIGNOR'S interest therein in exchange for consideration previously tendered, the receipt and sufficiency of which are hereby acknowledged;

ASSIGNOR HEREBY AUTHORIZES AND REQUESTS the Commissioner of Patents and Trademarks to issue said Letters Patent to ASSIGNEE as assignee of the entire interest, for the sole use and benefit of ASSIGNEE, its successors and assigns.

ASSIGNOR HEREBY AGREES (a) to communicate to ASSIGNEE, its successors and assigns, or their representatives or agents, all facts and information known or available to ASSIGNOR respecting said invention or inventions, improvements, and modifications including evidence for interference, reexamination, reissue, opposition, revocation, extension, or infringement purposes or other legal, judicial, or administrative proceedings, whenever requested by ASSIGNEE; (b) to testify in person or by affidavit as required by ASSIGNEE, its successors and assigns, in any such proceeding in the United States or a country foreign thereto; (c) to execute and deliver, upon request by ASSIGNEE, all lawful papers including, but not limited to, original, divisional, continuation, and reissue applications, renewals, assignments,


powers of attorney, oaths, affidavits, declarations, depositions; and (d) to provide all reasonable assistance to ASSIGNEE, its successors and assigns, in obtaining and enforcing proper title in and protection for said invention or inventions, improvements, and modifications under the intellectual property laws of the United States and countries foreign thereto.

ASSIGNOR HEREBY REPRESENTS AND WARRANTS that ASSIGNOR has the full and unencumbered right to sell, assign, and transfer the interests sold, assigned, and transferred herein, and that ASSIGNOR has not executed and will not execute any document or instrument in conflict herewith.

ASSIGNOR HEREBY GRANTS to the law firm of **Fish & Richardson P.C.** the power and authority to insert in this Assignment any further identification which may be necessary or desirable to comply with the rules of the U.S. Patent and Trademark Office for recordation of this Assignment.


