DOES HEREBY CERTIFY:

FIRST: That this corporation was incorporated on the 26th day of May, 1987, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That this corporation owns all of the outstanding shares (of each class) of the stock of TEXAS ALKYLS, INC., a corporation incorporated on the 10th day of April, 1959, pursuant to the General Corporation Law of the State of Delaware.

THIRD: That this corporation, by the following resolutions of its Board of Directors, duly adopted by the unanimous written consent of its members, filed with the minutes of the Board on the 2nd day of December, 1991, determined to and did merge into itself said TEXAS ALKYLS, INC.;

FURTHER RESOLVED, that the proper officers of this corporation be and they hereby are directed to make and execute a Certificate of Ownership and Merger setting forth a copy of the resolutions to merge said TEXAS ALKYLs, INC., and assume its liabilities and obligations, and the date of adoption thereof, and to cause the same to be filed with the Secretary of State a certified copy recorded in the office of the Recorder of Deeds of New Castle County and to do all acts and things whatsoever, whether within or without the State of Delaware, which may be in anywise necessary or proper to effect said merger.
