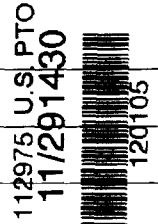


ASSIGNMENT
