**ASSIGNMENT**

**WHEREAS, WE, ABOU UL AALA AHSAN BUTT, STEVE R. BRAMWELL, AND BRIAN T. 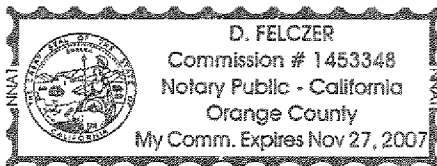

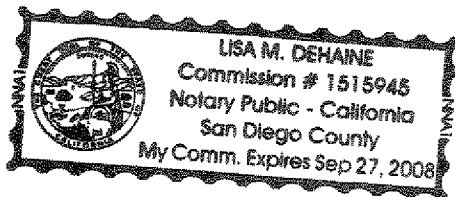

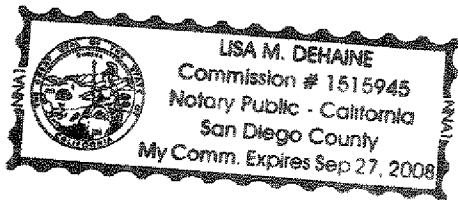
