
ASSIGNMENT OF INVENTION

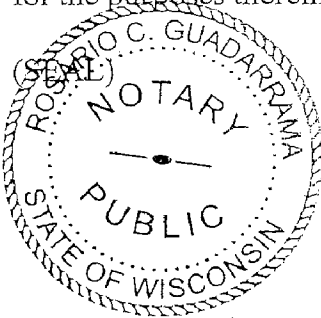

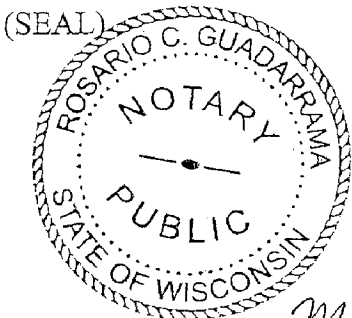

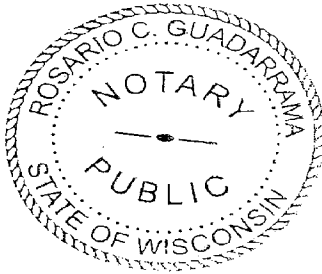
