ASSIGNMENT

WHEREAS, I, Bodo Odendall, a citizen of the Federal Republic of Germany, residing at Bachweg 14, 85114 Buxheim, Federal Republic of Germany, have made a certain invention entitled Process for the Control of Charging and Discharging of an Oxygen Reservoir of an Exhaust Gas Catalytic Converter, for which I am about to make application for letters patent of the United States of America; and

For the same consideration, I hereby covenant and agree that I will and that my legal representatives shall execute and deliver any and all application papers, assignments, powers of attorney and other instruments that said Audi AG, may consider necessary or advisable to secure letters patents of the United States of America for said invention, and any continuations, continuations-in-part, divisions, reissues, extensions and renewals thereof, and to vest and confirm in said Audi AG, the full and complete legal and equitable title to said invention, application and letters patents, without further consideration than that now paid but at the expense of said Audi AG.
