All of the above-mentioned rights, titles, and interests are to be held and enjoyed by the Assignee, for its own use and behalf and the use and behalf of its successors, legal representatives, and assigns, to the full end of the term or terms for which Letters Patent or Patents may be granted as fully and entirely as the same would have been held and enjoyed by the Assignors had this sale, assignment, transfer, and set over not been made;

AND for the same consideration, the Assignors authorize the Assignee to make application for such protection in its own name and maintain such protection in any and all

AND for the same consideration, the Assignors hereby consent that a copy of this Assignment shall be deemed a full legal and formal equivalent of any document which may be required in any country as proof of the right of the Assignee to apply for patent or other form of protection for said inventions and to claim the aforesaid benefit of the right of priority;

AND for the same consideration, the Assignors hereby covenant and agree to and with the Assignee, its successors, legal representatives, and assigns that, when requested, the Assignors shall, without charge to the Assignee but at its expense, sign all papers, and do all acts which may be necessary or desirable in connection with the above-mentioned applications, patents, or other forms of protection;

AND the Assignors hereby authorize and request that the Potomac Patent Group PLLC insert in the spaces provided above the filing date, attorney's docket number and other identifying indicia of the Application if absent;

AND the Assignors hereby request that the Commissioner of Patents issue any and all said Letters Patent of the United States to the Assignee as the Assignee of said inventions, the Letters Patent to be issued for the sole use and behalf of the Assignee, its successors, legal representatives, and assigns.
