ASSIGNMENT OF PATENT


Whereas, Douglas F. Fenton, D.D.S., an individual, (hereinafter "ASSIGNOR") is the owner, by assignment of eighty-six percent (86%) of US Patent No. 5,499,633, issued March 19, 1996, for "Anti-Snoring Device With Adjustable Upper and Lower Relational Members" (the "Patent"), and Bernard M. Kramer, M.D. and Jill H. Kramer, Trustees of the Kramer Family Trust UDTD 2/25/97, (hereinafter collectively referred to as "ASSIGNEES"), are the owner of fourteen percent (14%) of the Patent.

Whereas, ASSIGNOR desires to assign and transfer a percentage of its interest in and to the Patent, plus any reissues or reexaminations thereof, together with all rights of action, in law or in equity, for any past or future infringements, and together with the right to claim or obtain for the exclusive benefit of said ASSIGNEE, all damages owed by infringers, for any action for infringement committed before or after the present assignment, to ASSIGNEES, so that ASSIGNEES will thereafter own seventy-five percent (75%) of the Patent.

Whereas ASSIGNEE is desirous of acquiring an additional percentage in and to the Patent.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, said ASSIGNOR does hereby assign unto said ASSIGNEES, their successors, assigns and legal representatives, sixty-one percent (61%) of ASSIGNOR's right, title and interest in and to United States Patent 5,499,633, plus any reissues or reexaminations thereof, together with all rights of action, in law or in equity, for any past or future infringements, and together with the right to claim or obtain for the exclusive benefit of said ASSIGNEE, all damages owed by infringers, for any action for infringement committed before or after the present assignment.
