Preliminary remark

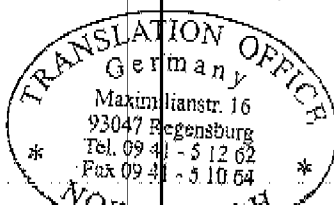

The name of the company shall be changed to Degussa Construction Chemicals GmbH.

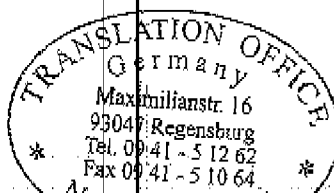
Accordingly, the content of para. (1) in § 1 (name and registered office) of the articles of association of the company shall be modified; para. (1) now reads as follows:

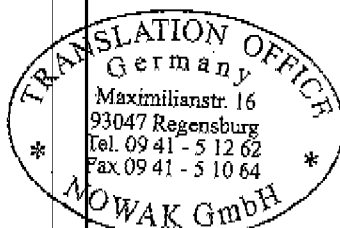
