ASSIGNOR hereby authorizes and requests the patent office of the country in which this Assignment is recorded to issue all patents issuing from such patent applications to ASSIGNEE or its successors or assigns.

ASSIGNOR hereby agrees to execute any papers, provide any information and testify in any interference or litigation at the request of ASSIGNEE, its successors, assigns and legal representatives, when deemed essential to ASSIGNEE's, its successors', assigns' and legal representatives' full enjoyment, protection, enforcement and title in and to such invention, patent applications, issued patents and rights hereby transferred.

ASSIGNOR furthermore agrees upon request of said ASSIGNEE, its successors, assigns or legal representatives, and without further remuneration, to execute any and all papers desired


