

STATEMENT OF SECURITY INTERESTS IN PATENT RIGHTS


On February 22, 2006, Precedent Gaming, Incorporated (“Precedent Gaming”), Kathleen Nylund Jackson (“Ms. Jackson”), and Kent Miles Jackson (“Mr. Jackson”; Precedent Gaming, Ms. Jackson, and Mr. Jackson collectively, the “Debtor”) entered into two security agreements, each entitled “Security Agreement” (collectively, the “Security Agreements”), with Lee A. 
