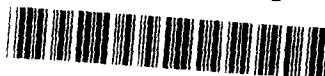

ASSIGNMENT

Whereas We, Ernest M. Yazigi, whose residence address is 1 Longfellow Place #1621, Boston, MA 02114, and Anas M. Shaar, whose residence address is 325 Union Street, Braintree, MA 02184, have made certain inventions or discoveries (or both) set forth in an application for Letters Patent of the United States of America entitled DENTAL IMPLANT AND DRILL FOR FORMING SOCKET FOR THE SAME, identified by Cesari and McKenna File No. 130038-0002U, which application was executed by us on even date herewith; and




