


## ASSIGNMENT

WHEREAS, we, William C. Kennedy, III and Robert J. 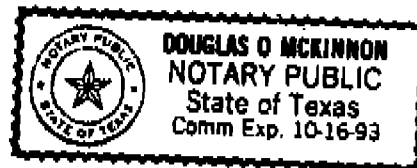
