This assignment shall have an effective date of September 14, 2003.

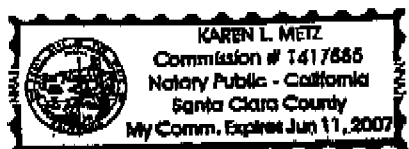


