TO: RALPH MUNRO, The Secretary of State of the STATE OF WASHINGTON:

Pursuant to the provisions of RCW 23B.10.030 of the Washington Business Corporation Act, the Articles of Amendment to the Articles of Incorporation of GARGOYLES ACQUISITION CORPORATION are adopted for the corporation:

1. The name of the corporation is GARGOYLES ACQUISITION CORPORATION.
2. The amendment to the Articles of Incorporation adopted by the corporation is as follows:

Revise the Articles of Incorporation to read:

1. The name of the corporation is: SUNGOLD EYEWEAR, INC.
2. This Amendment was adopted unanimously by the sole shareholder pursuant to a Consent in Lieu of Special Meeting of the Shareholder dated April 22, 1997, in accordance with the provisions of RCW 23B.10.030. and RCW 23B.10.040.
