PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT is made this 7th day of March 2006 by Antenex, Inc., an Illinois corporation ("Assignor"), in favor of ANT Acquisition Corp., a Delaware corporation ("Assignee").

WHEREAS, Assignor and Assignee have entered into that certain Asset Purchase Agreement dated as of the date hereof (the "Purchase Agreement"), pursuant to which Assignor agreed to transfer and assign, and Assignee agreed to purchase and accept from Assignor, the Assets (as defined in the Purchase Agreement);

WHEREAS, the Assets include, among others, certain patents, applications therefore, and draft patent applications held by or for use by Assignor, which patents and applications are listed and described in Schedule A attached hereto (the "Patents");

WHEREAS, Assignee desires to acquire the entire right, title and interest in and to the Patents; and

WHEREAS, in order to evidence the acquisition of Assignor's right, title and interest in and to the Patents, Assignor desires to execute this Patent Assignment in favor of Assignee.

NOW, THEREFORE, for good and valuable consideration paid by Assignee to Assignor, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. **Defined Terms.** Unless otherwise defined herein, capitalized terms used herein shall have the meanings ascribed to them in the Purchase Agreement.
2. **Assignment.** Assignor does hereby sell, transfer, convey, assign and deliver unto Assignee the entire right, title and interest throughout the world in and to the Patents and the inventions described therein, including, without limitation, all divisions, continuations, continuations-in part, extensions re-examinations and reissues thereof heretofore or hereafter granted and all applications for patent filed in any country or countries foreign to the United States claiming the priority of the applications from which the Patents issued, and all patents which have been or may be granted for the inventions in any country or countries foreign to the United States and all extensions, renewals and reissues thereof, together with the entire right, title and interest in and to any claims in law or equity, including, without limitation, the right to sue for and collect damages arising out of past, present or future infringement or other unauthorized use of the Patents.
3. **Recording; No Conflicts.** Assignor hereby authorizes and requests the United States Patent and Trademark Office record Assignee as the owner of the entire right, title and interest in and to the Patents, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives, and hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed and will not execute any agreement or other document in conflict herewith.

4. **Further Assurances.** Assignor agrees that, upon request by Assignee and without further consideration, Assignor shall execute all papers, instruments, documents and agreements, make all rightful oaths, testify on behalf of Assignee and do all other lawful acts necessary or appropriate to carry out the intent of this Patent Assignment, as well as provide such other material, information or assistance as may be necessary or desirable to carry out the intent of this Patent Assignment. Assignor hereby constitutes and appoints Assignee, and its successors and assigns, the true and lawful attorney of Assignor with full power of substitution in the name and stead of Assignor, but on behalf and for the benefit of Assignee, its successors and assigns, to demand and receive each and all of the Patents and registrations.

5. **Modification; Waiver.** This Patent Assignment may not be amended orally, but only by an agreement in writing signed by the party against whom enforcement of any waiver, change, modification, extension or discharge is sought.


6. **Severability.** If any provision of this Patent Assignment shall be invalid or unenforceable, in whole or in part, or as applied to any circumstance, under the laws of any jurisdiction which may govern for such purpose, then such provision shall be deemed to be modified or restricted to the extent and in the manner necessary to render the same valid and enforceable, either generally or as applied to such circumstance, or shall be deemed excised from this Patent Assignment, as the case may require, and this Patent Assignment shall be construed and enforced to the maximum extent permitted by law as if such provision had been originally incorporated herein as so modified or restricted, or as if such provision had not been originally incorporated herein, as the case may be.

7. **Miscellaneous.** This Patent Assignment shall be binding upon Assignor and shall inure to the benefit of Assignee, and its representatives, successors and assigns. This Patent Assignment may be executed in counterparts, each of which shall be deemed to be an original, but both of which together shall constitute the same agreement.



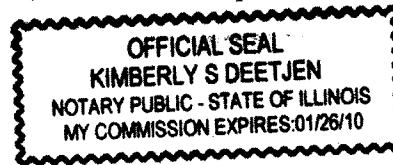
