All assigned rights, titles and interests in said invention are being supplied with no warranties, express or implied, including any warranty or merchantability or fitness for a particular purpose, except assignor does warrant that he has the right to enter this agreement, that assignor does own the rights, titles and interests in said invention and that assignor has the right to transfer the rights, titles and interests in said invention to the assignee.
